Offered wooden toys must be tested for compliance with the requirements of standards harmonized with Directive 2009/48/EC (Toys Safety Directive):

- EN 71-1: Mechanical and physical properties
- EN 71-2: Flammability
- EN 71-3: Specification for the migration of certain chemical elements and standards:

- EN 71-9 and EN 71-11 for organic chemical compounds present in wood (preservatives, dyes, amines).

In addition, if toys that have at least one function that depends on electricity, they must comply with EN 62115 - "Electric toys. Safety of use."

In addition, depending on the construction or components used, the toy may also be subject to other provisions.

Suppliers should therefore also pay special attention to the directives:

- RoHS (restricting the use of certain hazardous substances in electrical and electronic equipment),
- EMC (on electromagnetic compatibility)
- WEEE (on waste electrical and electronic equipment)
